I advise that provided the Reserve Bank of Australia Complies with its obligations under laws and Treaties to bring the Balance Sheet Values into the system under **Exhibit AMG 31**, the Board of Trustees of APFF has authorised me to immediately pay to your account held with the RBA the amount of the National Debt effective today's date as a Donation/Act of Grace/Gift.
