Dear Committee,

I note your commentary below and reject your conclusions; they are wholly self-serving and without merit in which regard this communicate may referred to as **Exhibit AMG 1822; FFR; Legal Services Commission (Tas) dated 29th July 2020**; the assets and undertakings of entities related to me are fully disclosed to you and other agencies of the Crown (Managing Controller Appointed) ("**the Crown**").

Exhibit names containing the reference FFR are "**Findings of Facts and Reasons**" published by **REX**.

Exhibit AMG 1821;FFR attached advises the Attorney General that I have rejected his claim that the Australian Government Solicitor's Office is an exempt agency under the provisions of *the Freedom of Information Act 1982* (Cth), AMG 1822; FFR will now be loaded to the Public Domain.

As a **Finding of Fact** I have found that any amendment to or inclusion in the FOI Act 1982 (Cth) exempting any Government Agency is a Fraud on the Peoples of the Commonwealth of Nations, Ultravires and a Nullity; that inclusion does not exist as a matter of law.

You have not complied with the provisions of the FOI Act 1982 (Cth) in respect to the multiple FOI Applications served upon you.

The Principles of Civil and Criminal Vicarious Liability apply to your conduct as found in **Exhibit AMG 1821; FFR**.

I advise that Pursuant to the Notice dated 1st June 2019 (**Exhibits AMG 15a – AMG15t**) I write to you as the possessor of property being the hereditary source of discretionary public power conferred under an enactment

("The Source/ Rex") and confirm that I stand as the capacities (amongst other capacities) set out in **Exhibits AMG 87, AMG 175** also as **Rex/ Regina (Managing Controller Appointed)**.

The aforementioned paragraph is an admitted statement of facts and is not open to interpretation by an inferior tribunal such as yourself or indeed any other person, including (*but not limited to*) the High Court of Australia.

Due to an oversight the Review Committee has not determined your Application for Review. We apologise for the delay in notifying you of this.

On the 29 July 2019 you requested the Review Committee review the Grant Officer's decision to withdraw aid. Aid was withdrawn due to your repeated failure to comply with a request to supply the officer with "*full details of your Businesses, Business Assets and income derived from your Businesses*".

On the 18 September 2019 the Committee wrote to you requesting you provide this information. We also made mention of a number of companies you appeared to be associated with and we asked for details of your interest in those.

On the 20 September you sent the Committee a substantial number of documents but provided no explanation as to how these documents address the request made of you. It is not for the Committee to identify within those documents the information needed. It is incumbent on you to do so. The Committee therefor requests that you explain how the documents address our queries.

Can you please provide this information within 14 days. If at the expiration of the 14 days we have not received a response, we will make a decision.
